An "Associate Honorary Member" may be a person that does not qualify for membership described by Article 2.01 but is recognized for a meritorious public service or for notable or meritorious service to The Group.

They shall not be required to pay dues.

Associate Honorary Members will not be eligible to vote for any Association matters.

Associate Honorary Members shall be passive at Association meetings except for Good and Welfare announcements
